Reviewed COVID-19 guidelines and procedures with staff. Recommended that educators remove all items that cannot be properly disinfected (cardbard, wood chips, pine cones, leaves, dolls with hair, doll clothing/anything material etc). Also reviewed group logs and cleaning schedules.

Some child profiles are missing the addresses of people who have permission to pick them up / addresses of emergency contacts. These must be added. Doctor's information must also be added.

Discussed with administrator that cushion floor is beginning to lift in some places. This will be discussed with public health for their next inspection.
