- Visit to the facility for a monitoring inspection.
- Ratio was respected during the visit.
- -When an on-going medication treatment is given to a child, medication must be into the original manufacturer's container or the original prescription label. Appendix 6, into the operator's manual must be filled by the parent. Once the appendix is filled a picture will be sent to the QAM.
- Daily incident log is maintained; parents are advised of the incident and signs the daily log.
- Educators were engaged with children during activities.
- Employee files must have all the required documents, once the SD check for a new employee is received a copy will be sent to the QAM. The educator cannot be on site before the SD check is received.
- Fire drills, outdoor checklist and first aid supplies checks are done monthly.
- First aid certificate is up to date for all employees.
- Learning stories posted highlights children's recent learning and interests.
- Children's guidance is done a respectful and positive way.
- Indoor space provides a variety of materials that are at the children level, the zones are welcoming and inviting for children to play and create.

## Observations:

During the visit, children were into free play, the two's and infants were napping. All children were having snack when I was leaving.
