<p><b>General Comments</b></p> <p>Visit to the facility for annual inspection.</p> <p>Ratio was not respected upon arrival in the infant group. A two year old in this group removed and placed with the preschool group in order to be compliant.</p> <p>Two children's soothers were sitting on a shelf without label or container. When not in use these must be on stored separately and labelled for each child. The soothers were placed in bags with names on them during the visit.</p> <p>If a child with an allergy requires an EpiPen staff must collaborate with the parent to ensure that the EpiPen is on site.</p> <p>Discussed with a staff member the entry way to the facility (at the top of the stairs). The floor is getting soft and could possible become a safety hazard. Staff member confirmed that this is going to be repaired in the next few weeks.</p> <p>Recommending children's profiles be revised, a few are missing medicare number and complete doctors information.</p>
