<ul> <li>-Visit to the facility for a regular spot check</li> <li>-Ratio was respected during the visit</li> <li>-Operator is notified by the parent the reason why the child is absent, whether it's sickness or another reason</li> <li>-When a child who becomes ill, he/she is supervised and separated from the other children. That child is to be picked up within one hour of notification to parents.</li> <li>-Management of potential illness forms are completed as required, discussion and explanation with the operator on appendix 11 &amp; 12 in the operator's manual.</li> <li>-Parents are advised when a child has a communicable disease or illness, center does use the notice of illness form (appendix 13, in the operator's manual)</li> <li>-We also talk about the importance to give all parents the appendix 14-Managing illness in ELC facilities- parent' s/guardian's role.</li> <li>-A complete first-aid kit and a phone are always accessible on site and on outings.</li> <li>-No hot beverage was found in the children's indoor and outdoor play area</li> <li>-Each child has an easily accessible space for personal belongings, which is labeled with the name of the child and used only for the intended child.</li> <li>-Learning stories posted highlights children's recent learning and interests, they are presently working on</li> <li>-Discussion with the educators on different alternatives on guidance of the children, solutions were brought up and staff feels confident that they are on the right track.</li> <li>-The administrator and educators have a valid first aid certificate and a valid CPR certificate</li> <li>-More than 50% of the staff has their ECE certificate or the equivalent</li> <li>-The gate way to the outside space is clear and the door opens and closes and does provide children an enclosed space to play all year long.</li> <li>Observations: When arriving at the center, children were into free play.
