<p>-Afternoon visit to the establishment for an unexpected monitoring inspection</p> <p>-Ratio was respect during the visit.</p> <p>-When acetaminophen is administered to a child, the consent form is signed by the parent and kept into the children file.</p> <p>-Administration of medication records are evident</p> <p>-Medication is stored in a toolbox that is locked and inaccessible to children</p> <p>-Prescribed medication is labeled with the doctor's name, instructions, and the time period for use</p> <p>-Non-prescribed medication are in the original child safe container with the original label and labeled with the child's name and dosage</p> <p>-During the visit, it was observed that all educators are engaged with children at their level providing support and having conversations.</p> <p>-In the entrance and in both rooms, evidence of purposeful planning based on children's interest and learning, invitation, photos and learning stories were posted.</p> <p>-In the outdoor play area children have more than one type of surfacing to play and explore.</p> <p>-Staff confirms that materials are taken out with them when going outside. A large trolley offers a varied and sufficient material quantity for children present</p> <p>-A broken spool was found in the playground; metal spokes were exposed. Staff confirms that it will be taken out of the fenced in space. A picture will be sent to licensing staff confirming that it has been done.</p> <p>-In the fenced in space a rope is attached to a large tree branch, it was suggested that the operator look into the CSA standards or to confirm that it is install according to the manufacturer's instructions.</p> <p>Observations: When arriving at the center, preschool children were eating their snacks. Once they were done, they went outside to play. The afterschool arrived, washed their hands and got ready for snack, once they were done eating, they went outside.</p>
