Inspector observed children during outside play at the Rothesay Commons playing soccer, creating "dandelion tea", and playing on the park's stationary equipment.

Inspector also observed the children during inside play: planting grass, having snack, engaged in dramatic play. Both of the school-age learning indoor environments have a wide variety of age-appropriate materials for the children to interact and engage with.

Educators were observed by the Inspector to be fully engaged with the children, tending to their needs and speaking kindly to them.
