22 The daily routine of a licensed facility shall include (a) outdoor play for at least one hour in each four-hour block of time when the majority of children receiving services are in attendance except in the following circumstances: (i) the wind chill is below -20 °C; (ii) the temperature is below -20 °C; or (iii) the temperature is 33 °C with humidity or above.	22(a)	Jan 27, 2025	
Comments: It was observed in both Preschool rooms (upstairs and downstairs) that the children did not go outside during their time as this program. The posted daily routine indicates that children to outside from 8:30AM-9:00AM. The temperature with the windchill was not below -20 but was -14. Inspector discussed with Educator that the time the children go outside can change to the end of the day before they depart. It was also discussed to ensure that the children have adequate winter attire with them such as snow pants, hats, mittens, boots and jackets. Educators indicated that they sometimes take the children for walks instead of using the fenced in play area, which is accepted. However, children must still be dressed appropriately for the winter weather with snowpants, jackets, hats, mittens, boots. Etc.

<b>General Comments</b>  A monitoring inspection occurred today on the preschool portion of this license. Discussed curriculum planning with the Educators. Handwashing was observed occurring several times during the inspection. Fire Drills were observed completed. Positive interactions between the Educators and the children were also observed.
