General Comments

Renewal Inspection:

Jack's Room: The children were observed playing with trucks, coloring, and playing in the dramatic play area. The educator's set out a sensory bin with the book "Scarecrow Pete". The children used tweezers to search for baby crows as they placed them in a basket.

Jackson's Room: The children were observed singing and engaging in play with the children. Invitations with books and materials were displayed around the classroom. The children were observed playing with cars and trucks.

Margaret's Room: The children were observed washing hands before snack. The educators were observed reading the book "The Tree That Grew to the Moon". The educator asked questions as she read to the children. "What do you see?", "What do you think?". In the art area there was an invitation set out with the book "Skin Like Mine". Next to the book was different shades of paint to match several types of skin tones.

Peyton's Room: The children were observed coloring with markers as their educator set up a fall invitation to play with for when they returned from outside play. On the table there was a book called "The Giving Tree". Beside the book the educator created two trees out of cardboard with different sized leaves and a variety of natural materials such as, acorns, pinecones, leaves, and bird seeds. The educator was observed bringing indoor materials such as, paint, paper, blanket, books, and fidgets outside for the children to play with.

Joshua's Room: The children were observed as they finished snack. The children were observed playing in the dramatic play center. The educator was observed engaging in play with the children asking, "Can I please have some water?". The children were also observed using their fine motor skills to manipulate busy boards.

Grandpa's Room: Two infants were only in attendance for about an hour as they are currently transitioning. The Inspector did not engage. Once the children left the Inspector observed the educator cleaning and organizing toys. Invitations with hedgehogs was displayed around the classroom.

Hanna's Room: The children were observed playing outside in the sand with trucks. The educators were observed engaging in play and conversations with the children. "What does it sound like when you drive the truck on the table over the sand?", "What does it feel like?".

Hand washing, diaper changing, and naptime routines were observed.

The following records were reviewed: Incident logs, fire drills, educator professional learning hours, infant toddler daily sheets, nap sheets, and daily attendance sheets.

All staff files were viewed, and a random review of the children files was completed.

The Inspector discussed the following with the Operator:

- 1. Professional Learning Hours- The Operator shared that the remaining staff who require hours have been registered for upcoming sessions and the hours will be completed by October 31, 2025.
- 2. Diaper Changing- The Operator has agreed to go over diaper change procedures at the next staff meeting.
- 3. Art Materials- The Operator will ensure that art materials are always restocked and accessible to the children throughout the day.
- 4. EpiPens- The Educators are to ensure that the emergency management plan is signed and reviewed yearly. Educators are to request a new EpiPen once the EpiPen has expired.
