General Comments

Monitoring Inspection- COVID-19 Recovery Phase.

Children and educators engaged in activities within classrooms and preparing for outdoor play during monitoring inspection. A variety of activities are accessible and invitations are set up to invite children's engagement, Documentation demonstrating recent activities and learning posted throughout the play environments and hallways.

Ensure materials that cannot be sanitized are discarded or replaced daily.

Hand washing observed during inspection.

General Comments

Additional cleaning charts are present and completed daily. The environments and hallways were very clean and it is evident staff are working hard to ensure the environments are clean and safe for children. Group logs current and completed correctly.

Based on observation by Quality Assurance Monitor during monitoring inspection today and further conversation and collaboration with public health, moving forward, active screening of parents who are entering the building is required. As per the Recovery guide document, drop off and pick up should be managed outside, unless an adult absolutely needs to come into the facility. If parents are entering the building recommended that during busiest drop off and pick up times an assigned staff screens parents entering the building. At other times throughout the day, the entry door should be locked and visitors requested to call for screening and entry into the building.

When social distancing is not possible with the large number of children and parents entering the facility each day, community masks should be worn by adults. (As per page 4 of the Covid-19 Recovery phase Guide).
