### General Comments

There is evidence in the rooms of current interests that are being explored with the children and their educators (documentation and materials). Lovely posted documentation in the hallway reflecting the children's learning. Books being displayed in the different interest centers based on the topics of interest enhances the children's learning through increased opportunities for conversation, exploration and the possibility for new interests to be discovered. The children's learning environment is being valued and seen as being the third teacher by demonstrating the children's art, print and creations that are posted in combination with props and materials that

are available through invitations.

The children were observed to engage in a variety of activities today, both inside and outside. The routine of the day went smoothly and the children appeared to be very familiar with the routine. All children were observed to be participating in activity and circulating the interest centers freely.

The outdoor wooden play house requires maintenance to be completed in the spring (replacing rotten/missing cedar shingles, scraping and painting of the structure).
