### General Comments

Renewal inspection completed today.

Documented evidence supports the children's involvement in the exploration of a variety of topics of interest within their classrooms. The children were reporting on some of their learning and engaged enthusiastically in conversation. Educators have included the children in documentation and this ultimately promotes reflection and enhanced learning opportunities. Observed a great deal of interest in books, as well as a read-aloud that challenged the meaning of words and the evaluation of feelings.

The children enjoyed indoor and outdoor play today. Transition times were fluid and educators were available at the children's level to participate along with the children and to guide them as needed. Kind and respectful interactions were observed in addition to encouraging the children's efforts.

General Comments

Recommend painting the trim of the outdoor wooden playhouse in the spring.
