Monitoring inspection conducted today. Full monitoring inspection was not able to be completed due to concerns regarding child to staff ratio and adequate supervision. QA Monitor will return for a complete monitoring inspection in the near future.

General Comments

When children are transitioning to a new group or new room ratio is calculated based on the child's current age.

As per section 8.1.2 of the Operator Manual:

- * Children transitioning are included in the new group by gradually increasing the length of time until the transition is complete.
- *Children transition under the following conditions:
 - the maximum group size for the room is not exceeded.
 - transition period does not exceed 2 (two) weeks.
 - a record of the child's time in the new room is indicated on the attendance sheet of that room.

At the beginning and end of the day when attendance is lower, infants must not be mixed with any other age group.
