<p>General Comments</p> <p>A renewal inspection occurred today.</p> <p>During the inspection, Inspector observed the children and educators in Room 6, 7 and 8.</p> <p>In Room 6, Inspector observed documentation displayed on the walls of the children's learning and interests. Pictures and stories of the children learning about automobiles and animals were observed. Webs building on the interests as well as pictures of the children playing "bus" in the outside play area, playing with cars/vehicles on a cardboard road were observed. Pictures of the children engaged in "reading" books about animals and finding animals in the Tuff Tray hidden in the snow was observed. Pictures and stories of the children exploring colors with paint and cotton balls and sensory exploration with paints/textures with their peers was also displayed.</p> <p>In Room 7, Inspector observed children's learning is documented and displayed on the walls. Photos and learning stories of the children engaged in exploring the snow outside, painting the snow inside in the tuff tray, pictures of children matching shapes, searching for shapes in the learning environments, and gross motor activities of the children jumping into shapes created on the floor by the educators using tape. Inspector observed samples of the children's open-ended art/paintings were displayed throughout the room.</p> <p>Room 8, Inspector observed that the children are learning about colors and shapes. Pictures and learning stories of the children exploring mixing colors to create new colors in the snow in a tuff tray. Building with playdough and multicolored pasta and exploring bubbles. Samples of the children's art/painting were observed displayed on the walls as well as learning stories with the children engaged in a fine motor activity of cutting using scissors. Inspector also observed pictures and captions of the children exploring the snow in the outside play area.</p> <p>Educators in all rooms, were observed by the Inspector, down at the level of the children, engaged in their learning and play. Singing was also observed occurring in the rooms. Educators and children were also observed going for a neighborhood walk and utilizing the outside fenced play area at the childcare facility.</p>

General Comments

Inspector observed that in each of the learning environments there are age-appropriate materials for the children to interact and engage with. Defined interest centers were also observed in each of rooms.

Educators were observed by the Inspector, speaking kindly and appropriately to the children using positive child guidance techniques.

All staff files were reviewed during the inspection, and a random review of children's files occurred. All files were verified completed. Inspector verified that all items required under the Early Childhood Services Act/Regulations for the renewal of a license was in compliance at the time of the inspection.

Facility is recommended for license renewal, pending the recommendation from Fire.
