Comments: A cleaning product was found under the bathroom sink secured by a child safety lock. All toxic products, chemical products and cleaning supplies are to be locked and inaccessible to children. Operator removed the bottle and stored it in the locked closet. Deficiency is now compliant			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Oct 02, 2020	
Comments: Some water bottles brought from home were not labelled with the child's name. In order to ensure the child uses the correct water bottle each water bottle must be labelled with the child's name.

Comments: Food brought from home was labelled but some items were not placed in the refrigerator. Operator placed items in the refrigerator and advised educators to place items in refrigerator once they arrive. Deficiency is now compliant			

General Comments COVID-19 Inspector was fully screened upon arrival at the centre. All required Covid documents are available and accessible on site. Family member group logs have been created but a few didn't have the contact number. These need to be complete and reviewed on a regular basis. Inspector observed positive interaction between the educators and the children while playing outside. Educators shared with the inspector how they have been using the outdoor play park fence as a communication tool for
