Comments: One bottle of Miracle Gro fertilizer is found in a cabinet unlocked. All toxic products must be locked. Administrator immediately locked the bottle in the locked cabinet Deficiency is now compliant.

Comments: 6 out of 7 water bottles were not labelled with the children's name. All personal belongings need to be identified.

Comments: 3 out of 8 children's lunch box weren't identified with the children's name. All food and personal belongings need to be identified with the children's name.
