<p><b>General Comments</b></p> <p>Upon licensing staff's arrival, the 4- and 5-year-old group was practicing for their preschool graduation. The educator encouraged the children throughout the activity while they sang ABC songs and danced. Children who did not want to participate were engaged in colouring and crafts at the table. The group then transitioned to lunch by washing their hands and sitting at the tables.</p> <p>The other two preschool groups transitioned to snack. In the youngest preschool group, a parent visited the program to read a story to the children. The program shows good community involvement, with several learning stories displayed about parents and community members coming into the centre to share experiences and activities with the children. After the story, the children participated in circle time and sang songs together. Invitations to play included crafts, a sensory table, and LEGO.</p> <p>Following snack, the older preschool group was observed using natural loose parts to build animal pens. The educator supported the children's ideas by asking questions and suggesting different loose parts they could use. Another preschool group was playing Spot It, Hungry Hungry Hippos, and with toy cars alongside the educator.</p> <p>Before lunch, the children washed their hands, used the washroom, and sat at the tables with their lunch boxes. One preschool group participates in a rest period, and cots were set up for the children after lunch. Due to the rain, one group spent time outside under the covered canopy, where they drew with chalk.</p> <p>Licensing staff reviewed staff and children's files and found all required documentation to be in compliance. Monthly fire drills are being completed as required.</p> <p>Licensing staff recommends the program for renewal.</p>
