General Comments
<p>A Monitoring Inspection was completed this afternoon. QAM arrived before the children and observed the inside environment. Several learning invitations were set up and ready for the children's arrival - popsicle stick art station, paper and mark making materials, and a Barbie hair salon. A cozy reading room was observed, a room full of Barbies and Barbie accessories, and a room with toy vehicles, and gross motor activities. While outside, QAM observed the arrival of the younger group. This group was observed playing outside - playing on the swing, sitting on the big rock, playing with balls, and a group of girls were observed sitting together, under a tree, talking, smiling, and laughing. Inside, children were observed creating hair styles with the large barbies, drawing / coloring, and taking part in arts and crafts. For snack, children were offered bagels, with butter, jam, and or cream cheese. Educators were engaged with the children – sitting with the children, talking to the children, offering choices, and providing compliments and praise. The older group played at the school playground after school, and they were not observed today.</p>
