General Comments

A Monitoring Inspection was conducted this afternoon. Upon arrival, all school aged children were outside, at the school playground. While the children played at the playground, QAM observed the inside environment. The inside environment contained several well-defined learning / play centers - arts & crafts, building, dramatic play, cozy reading room, and a collection of games. Two tabletop activities were set up and ready for the children's arrival. One table contained a Loom Bracelet kit, and the other table contained a winter themed craft, with several arts & crafts materials and accessories. Examples of children's artwork were observed on the wall. Holiday themed decorations were observed throughout the facility. The older group of children arrived at the facility at 3:30PM. Handwashing procedures were observed. Today's snack was hashbrowns, ketchup, carrots, and ranch dressing. The children were also offered water and hot chocolate. The younger group of children arrived at the facility at approximately 4pm. The younger group were also observed washing their hands at arrival. After hand washing, the younger group went to the gym, for free play. In the gym, children were observed riding Plasma Bikes and Scooters. The Parent Board was observed and contained the following documents: the most recent Monitoring and Renewal Inspections, the daily menu, contact information, and the license. In the kitchen, a list of allergies was observed. Attendance Records were observed for both groups, and both were accurate. Positive child guidance techniques were observed, by all educators - educators conversing with the children, educators offering the children choices, and educators using positive language.
