General Comments

A renewal inspection occurred today. Licensing staff observed children being met at the school by the educators and walked back to the facility. The children entered their outdoor play area and had free play until they were ready to go inside. Inside the children engaged in multiple invitations set up, including a game that the children were blindfolded and found play spiders hidden in cooked spaghetti. The children ate cucumbers and granola bars for snack and most went back for seconds. Discussed with educators' safety concerns regarding walking from Leatherbarrow school with children. Recommending crosswalk sign for educator to hold at crosswalk on the blind hill. Also recommending operator reach out to district office as well as town of Hampton to address safety concerns.
