General Comments
<p>A Monitoring Inspection occurred in the afternoon on December 18, 2025</p> <p>The school age children were observed in both indoor environments, including during transitions between the two spaces. Transitions were supported by educators using visual cues and gentle verbal prompts. Upon arrival from school, the younger group transitioned to the main room, while the older group transitioned to the gym.</p> <p>Younger Group: The children were observed eating snack, today's snack was granola bars, with handwashing occurring beforehand. After snack, the children transitioned to free play, which included playing with dolls, doing art at the table, and playing a ping pong bingo game with their educator. The children then transitioned to the gym. In the gym, they were observed riding the plasma cars, playing basketball, and using the scooters. Educators indicated that the children are currently interested in iron beads, loom bands, and group games.</p> <p>Older Group: The children were observed engaged in a variety of activities in the gym, including playing basketball, riding scooters, playing badminton, and playing Four Square. The children then transitioned to the main room and were observed eating snack, with handwashing occurring beforehand. After snack, the children transitioned to free play, which included playing ping pong bingo alongside their educator and doing art activities at the table. Educators indicated that the children are currently interested in sports, art, and building with LEGO.</p> <p>A clearly visible and prominent area was designated for posting the facility's license, current monitoring reports,</p>

menu, and any orders for compliance. Additional documentation observed included incident logs, daily attendance records, two staff files, and records of evacuation and monthly fire drills.

A conversation took place with the Operator regarding the following:

- Recommending removing the weekly dates from the menu and replacing them with Week 1 through Week 4, using an arrow to indicate the current week, and placing a separate sheet beside the menu to record substitutions.
