Children are looking forward to having a party on Friday in celebration of valentines. The usual routine does include outdoor play, but today due to the temperature, they will probably go out in the afternoon. It is my understanding that SS has good enrolment for the school age program this school year. PD days and summer programming is in operation, however, the preschool and school program is closed during storm days.
