Comments:	Deficiency is now compliant. Licensing staff observed in the outdoor play area one of the handles on the children's shovel was broken and had sharp plastic part which would be a safety hazard. After discussion with the operator, it was decided to remove the shovel from circulation and repair the handle as the shovel is still usable. This was addressed during the inspection visit.						

## **General Comments**

## Monitoring report performed.

Administrator records were reviewed - attendance of staff and children is documented, incident reports are tracked (thank you for adding the time), outdoor check list completed monthly and awesome times observed on fire drills that are performed monthly.

Children were observed in outdoor play. Children were laughing and playing cooperatively with each other. Educators were engaged in children's play assisting with building a snow volcano using shovels and snow mold tools to collect the snow. The snow easily packs after yesterday's storm, so children were trying to roll the snow into balls to make a snowman. The Administrator is having a new mud kitchen built and will be purchasing implements this spring with the grant money they receive from the department.

There is an updated 'Prevention and Control of Communicable Disease Guideline' effective March 2023 - please review the changes with your educators so they are aware. A new staff managing illness policy is also required. Please update your staff health policy.

Licensing staff observed children and staff washing hands at prescribed times even when returning from outside and before sitting at the table to eat lunch. Once inside a conversation circle took place and all children participated and sang songs. the educator engaged children asking questions, listening and responding to

children. They also provided literacy opportunities when asking children the word that is opposite to - tall, large etc. Lots of positive conversation was observed while children ate lunch.

Appropriate child guidance was observed also during the visit when educators were observed using playful conversation, no thank you, responding by using our listening ears when our friends are talking and saying that is a good job.

All children were observed having a nap and or a quiet time. No child was forced to sleep and those that woke early were permitted to play at the table.
