Comments:	While observing the children playing in the outdoor environment, it was noted that the protective surfacing surrounding the climbing dome and the swings does not have the required protective surfacing according to the manufacturer's manual. Please ensure the mulch surrounding the swings and the climbing dome is replenished according to the manufacture's manual in order to maintain the safety of the children while playing in the outdoor play environment.					

General Comments

Licensing staff arrived at the licensed facility to conduct the yearly license renewal on May 4th, 2023.

When licensing staff arrived on the day of the inspection, the children were still arriving for the day. It was observed that all children, upon arrival, went into the bathroom to wash their hands.

The children were observed engaging in free play activities and a circle time. During circle time, if a child could not sit, the educators allowed the children to get up and play.

Licensing staff observed the children laugh and engage in rich conversations with their peers and educators. The educators used open-ended questions to enhance the learning during indoor and outdoor play and positive child guidance techniques were used throughout the inspection.
