<p>A Monitoring Inspection was completed this morning. Children were observed during inside play and snack. Upon entry, children were observed washing their hands. Before snack, children were also observed washing their hands. Children were observed painting, climbing, sliding, looking at books, relaxing in the cozy corner, and playing with animal figurines. An educator was observed reading two books to the children. Both educators were engaged with the children - sitting at their level, conversing, and taking part in activities. Several well-defined learning / play centers were observed - dramatic play, loose parts, gross motor, arts & crafts, bug investigation, and a yoga area. Educators stated that the children are presently interested in painting and playing outside. Several forms of documentation were observed – children's artwork, mark making, learning stories, and photos.</p>
