## **General Comments**

A Monitoring Inspection occurred June 12, 2025.

The children were observed in both the indoor and outside environments.

The children were observed using bubbles, using the trucks in the pea gravel pit, swinging on the swings and playing in the mud kitchen. Educators stated the children are currently interested in flowers, dramatic play, and bugs.

It was observed that two children had a conflict over a ball, both children were visibly upset. Educators were observed down at both children's level speaking calming. Educators gave the children time to self-regulate, educators demonstrated that they had a good understanding of positive child guidance, redirection techniques and facilitating problem solving. Children were guided to a solution and both children went back to playing with the ball co-operatively.

The room is set up and inviting, with various materials accessible to the children. Ideas from the web/learning story are reflected in the art area, library, kitchen and dramatic play areas. Books have been selected that reflect the children's interests.
