<p>A renewal inspection occurred today.</p> <p>The children were observed during the following times: Free play, snack, outside, washing hands, and lunch.</p> <p>The documentation around the classroom was current and reflected the children's on-going learning. Webbing titled: Connection, Trajectory, Transportation, and Transformation were present. It was evident through photos that the children have been learning about how things move, how things travel from place to place and cause and effect. By looking at the available learning stories, it was evident that the educators have a good understanding of the New Brunswick Curriculum Framework.</p> <p>During outside play the educators were observed using positive child guidance techniques. The educators were observed supporting children by helping them problem solve and encouraging them to talk to their peers to resolve conflict. The children were observed playing in the mud, playing with cars, and trucks, digging in the rocks, listening to music, swinging on the swings, and engaging in play with their educators.</p> <p>The following records were reviewed: Incident logs, fire drills, planning sheets, playground checks, and daily attendance sheets.</p> <p>A review of all staff and child files were completed.</p>
