Comments: All required information about the emergency contact address was added to the 5 child's files audited verified. However, 1 child's files verified was missing an emergency contact phone number. The operator must ensure that all children's files are fully completed. While on site, the operator received another emergency contact phone number by the parent, and it was added into the child file. Deficiency is now compliant.

Comments: The inspector and Quality Assurance Monitor was on site to verify the positive guidance. A plan by the operator has been made regarding this situation. The staff members, children and classes have been reconfigured to facilitate transitions. The QAM and inspector will contact the Early Learning Consultant to give support to the educators. Deficiency is now compliant.			
50(2) The operator of a licensed facility shall inform the parent or guardian of a child involved in an incident on the day the incident takes place and shall ensure that the parent or guardian signs the daily log to confirm their awareness.	50(2)	Dec 20, 2023	Jan 08, 2024
Comments: The inspector observed 3 daily incident logs signed by the parent on the same day of the incident. Deficiency is now compliant.
