Comments: The Quality Assurance Monitor was not able to observe the daily activities for 3 classrooms for the past weeks. Activities must be planned daily, and the daily program must be readily available for review by licensing staff.

Comments: In one staff file verified, the training qualification certificates and diplomas were missing. All educators must successfully complete the Introduction to Early Childhood Education Certificate or hold an Early Childhood Education certificate. A proof of registration for the Introduction to Early Childhood Education was printed and placed in the staff's file. Deficiency is now compliant

Comments: While verifying staff members' files, the first aid and CPR certificate was missing from 3 educators' files. Administrators and educators must hold a valid first aid and CPR certificate, and it must be inserted in their files.			
36(3) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall be equipped with the following: (b) a cot or nap mat appropriate for the height of the child for each child who is at least 15 months of age and under five years of age who takes naps.	36(3)(b)	Sep 09, 2025	Sep 09, 2025
Comments: The Quality Assurance Monitor observed a broken cot in one classroom. The broken cot was replaced. Deficiency is now compliant			

General Comments

The Quality Assurance Monitor is on site for a monitoring inspection. The ratio was respected during the inspection.

The Quality Assurance Monitor observed the following items:

- If the required documents are posted in a prominent and visible place in the facility
- Daily activities
- Rest area
- Checks
- Staff member's file

The Quality Assurance Monitor had a discussion with the administrator regarding designation requirements. The administrator confirmed that the Quality Improvement Plan is current, and all eligible educators are actively completing their required 10 hours of professional learning per renewal year.

The Quality Assurance Monitor observed the children playing in the outdoor play area. The children then transitioned to washing their hands and changing diapers for lunchtime (lunch box). The Quality Assurance Monitor also observed nap time and quiet time.
