## General Comments

The Quality Assurance Monitor is on site for a monitoring inspection. During the inspection, the quality assurance monitor was able to inspect the changes in the fence placement. The quality measured the space in order to confirm that the outdoor play area is sufficient for the number of children using the space. The fence was in good condition during the inspection and the gates were able to close and open easily. The latch to the

preschool fenced area was in good condition and the gates were kept clear for safe and efficient entry and exit. The door to the infant fenced area was not latching completely. This will need to be reviewed and fixed as all latches must be able to close easily. The operator will need to be mindful of the incoming snow and ensure that the children are not able to get over the fence due to snow build up.

During the inspection, the Quality Assurance Monitor verified 4 staff files and was able to confirm that the signed declarations and a copy of the staff members responsibilities and duties were in the staff files verified.

During the inspection, the Quality Assurance Monitor was able to verify the attendance records. The attendance records were kept up to date and absences and reasons for absences were properly noted on the attendance records. The Quality Assurance Monitor recommends that if the absences are indicated as non-related to illness that the specific reason also be documented.

During nap time, the children who were not sleeping were provided with books, board games and magnetic shapes to play with on their cot. Instrumental relaxation music was playing during nap time and the Quality Assurance Monitor observed the educators comfort children to help them fall asleep by rubbing their backs or speaking softly to them to remind them that it is time to rest.
