Quality Assurance Monitor was on-site to complete monitoring visit. QAM observed the following items:

- · Indoor play area materials and equipment
- Indoor Space
- Visible Postings
- Staff Member records
- Daily Routine
- Premises
- Storage Space

Operator states that renovations in the school-age play room began January 17th 2024 and should be completed by January 26 2024.

QAM and Operator discussed that any staff under the age of 19 must be supervised by another staff over the age of 19; QAM notes no staff under the age of 19 were on-site at inspection visit.

Operator and QAM reviewed requirements for designation renewal.

QAM observed children waking from naptime, engaging in free play, washing hands for snack, eating snack,
