Staff were observed engaging with children in a variety of ways: one educator was making slime with a group of preschool children, an afterschool educator was sitting with children to play a board game, other educators were supervising a quiet & peaceful rest area for younger preschool children during the rest period of the day. This demonstrates one of the broad-based learning goals of the NB Curriculum: valuing children.
