Comments: All of the audited child files have incomplete addresses for their emergency contacts. All child files must have two emergency contacts with complete addresses.

Comments: Three out of five audited child files are missing a copy of their immunization record or a copy of the exemption.

Comments: The kitchen doors have child proof safety locks. The kitchen doors must be locked with a key lock when not being used by staff.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Jun 17, 2021	
Comments: Toxic and cleaning products (house paint, Clorox, cleaning supplies) were found in the janitor's storage room which is locked with a plastic child proof lock. These products must be stored in a room that is locked with a key lock.

Comments: Three out of five audited child files are missing a copy of their immunization record or a copy of the exemption. This information must be obtained prior to the child's entry.			

General Comments

During the inspection, the Inspector observed, outdoor and indoor play, lunch , nap and quiet time.

The storage door next to the kitchen has a plastic child proof lock. The storage area has a door leading to the electrical room. The Administrator will follow up with the Fire Inspector to inquire if a key lock can be put on the electrical door. The Administrator will confirm with Inspector the recommended measures received from the Fire Inspector.
