The administrator immediately contacted the parents of the child and received a copy of the child's immunization record, which was inserted into the child file. Deficiency is now compliant

The operator must ensure that a copy of training qualification certificates and diplomas is included in each staff member file. The administrator shared that one staff member is currently enrolled in an ECE course and inserted a copy of the enrollment confirmation in the staff member file. The administrator also shared that the second staff member has completed the introduction to ECE course and inserted a copy of the certificate in the staff file. Deficiency is now compliant

The operator must ensure that the description of duties and responsibilities is included in each staff member file. The administrator immediately inserted a copy of the description of duties and responsibilities in the staff in question file. Deficiency is now compliant
