Comments: The inspector reviewed 12 children's files and noted that 3 files are missing the Medicare number and expiry date. All children's files must include the child's name, address, date of birth, and Medicare number. This is the second reminder; the administrator must ensure that all children's files are reviewed and completed, with no missing information.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (iv) the name, address and telephone number of at least two individuals authorized by the child's parent or guardian to pick up the child and to be contacted in case of an emergency if the parent or guardian cannot be reached,	24(1)(b)(iv)	Jun 19, 2026	
Comments: The inspector observed that, in 1 out of 12 children's files, both emergency contacts are located more than one hour away from the facility. All children's files must include the name, address, and telephone number of at least two individuals authorized by the child's parent or guardian to pick up the child and to be contacted in case of an emergency if the parent or guardian cannot be reached. This is the second reminder; the administrator must ensure that all children's files are reviewed to ensure they are complete and contain no missing information.
