Comments: During the follow-up inspection, the inspector observed rodenticide in a locked storage. During the inspection, the administrator removed the rodenticide from the facility. No rodent droppings were observed. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed rodenticide in a locked storage. During the inspection, the administrator removed the rodenticide from the facility. No rodent droppings were observed. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that art materials are easily accessible on low open shelves in all five classrooms. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed a bottle of hair gel in 1 of the classrooms. The inspector also observed cleaning products in the unlocked laundry room. During the inspection, the administrator placed the hair gel in a locked cabinet and locked the laundry room door. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed a coffee in a classroom. During the inspection, the administrator placed the coffee in a locked area. Deficiency is now compliant.
