Comments: During the renewal inspection, the inspector observed a bottle of WD-40 in a storage room which was not locked. During the inspection, an educator closed and locked the door where the WD-40 was stored. Deficiency is now compliant			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Nov 04, 2022	
Comments: During the renewal inspection, the inspector observed that four out of 10 water bottles verified were not labelled with the name of the child. The operator must ensure that personal belongings are labelled with the name of the child.
