Comments: During the renewal inspection, the inspector observed that the latest renewal inspection is not posted in a visible and prominent place in the facility. The administrator informed the inspector that they only posted the most recent inspection reports which are both monitoring inspection reports. The operator must ensure that the renewal inspection report and monitoring inspection report are posted inside the facility.

Comments: During the renewal inspection, the inspector observed that 5 reason for absence codes are missing on this week's daily attendance sheet and that the arrival time of one child is not specified. The operator must ensure that times are recorded immediately upon the child's arrival and departure, and that the record reflects all children present at any given time. The operator must also ensure that attendance records are completed, showing all absences and detailing the reason of the absence. During the inspection, an educator and an administrator wrote the reasons for absence and the missing arrival time on the daily attendance sheet. Deficiency is now compliant.

Comments: During the renewal inspection, the administrator advised the inspector that the facility offers transportation and that during the summer months children are transported to different parks and sport facilities around the Greater Moncton area. The administrator informed the inspector that parents are sent an online consent form but that a written signature is not required. The operator must ensure parents sign separate consent forms for field trips. These consent forms should outline the date, time of departure and return, destination and purpose of trip and any special considerations.

	acetaminophen. All other medications must be provided by the parent or guardian of the child and must be									
labelled with the child's name and the dosage.
