Comments: While on site at more than one occasion, the educators were not able to confirm to the Quality Assurance Monitor how many children was present. The Quality Assurance Monitor would ask the educator when a bus run would get to the daycare how many children were present at that moment. Each time the educator would tell a number to the Quality Assurance Monitor and when the Quality Assurance Monitor would count the children, the numbers would not match. Each time the Quality Assurance Monitor would count more children than the number that the educator presented to the Quality Assurance Monitor. The Quality Assurance Monitor explained to the educator that it's very concerning that educators are not sure how many children the educators are responsible for. The Quality Assurance Monitor also noticed that all of the children are on one attendance sheet and are not divided by groups, the Quality Assurance Monitor told the educators that if children were divided by the group on the attendance sheet that it would be a lot easier for educators to keep track of how many kids are in the group. The educator explained to the Quality Assurance Monitor that children are all on the same attendance sheet because children are not in fixed groups, the groups all depend on the gym schedule. The Quality Assurance Monitor had a discussion with the administrator and explained that a plan must be put in place to ensure that educators are aware of how many children are present in the group to ensure a proper supervision of children. Two different games were being played in the gym, one of them being king's court and the other was a form of baseball game. The Quality Assurance Monitor also observed positive interaction between educators and children.
