Comments: A few observations - some plug outlets need protective covers upstairs and downstairs. Paint is also chipping off the walls and needs repaired as difficult to clean and sanitize. The chair in the infant room also needs recovered or discarded. Currently this room is not being used as no babies on site but some are registered for fall. Foam blocks downstairs are chipped and soiled and must be discarded as it is difficult to clean and sanitize. I would recommend that all children should be wearing footwear for safety purposes ie. prevent slips, falls and/or stubbing toes.

General Comments

Renewal Inspection performed.

*Covid Recover Phase Guidelines are followed and children, staff and visitors are being screened and temperature checked prior to entry. Group logs are being tracked daily.

I observed as per the Covid phase guidelines that Household members living in the home have not been identified and placed in child files. this is a requirement for PH in the event of contact tracing.

*During my visit children were observed playing with their own sensory bins, listening to stories, washing hands in between activities, eating lunch and going down for a nap. Operator has purchased new nap mats for the children. I did not observed outside play today. I would recommend that children get outdoors in the early part of the day when it is forecasting high humidity temperatures. Today it is supposed to be above 33oC. It is my understanding that children were outside this AM.
