Comments: Cleaning products, Febreze, and body sprays were observed on high shelves in the bathrooms attached to the classrooms. Body spray was observed in a cupboard in the 3s/4s classroom. All cleaning products and other toxics were placed in the locked storage closet before the end of the inspection.

Comments: A hot beverage cup was observed on a high shelf in the 2s/3s' room. The beverage was disposed of before the end of the inspection.			

General Comments
<p>I attended the centre for their annual license renewal inspection on this date. They were enjoying their Halloween party and having lunch when I arrived. Staff were all engaged with children, sitting down on their level throughout the inspection. Educators supported the children when needed during mealtime but encouraged independence where possible. Educators set inviting stations up children to enjoy varied activities; in the 3s/4s' room stations included: varied types of stacking blocks, sand play, and colouring. Each classroom had ample accessible toys, books, art supplies, puzzles, and other activities available within the children's reach.</p> <p>I observed Halloween themed art activities on the walls in all the classrooms, demonstrating the children's learning. I observed portfolios with more of the children's learning demonstrated, including practice of writing and pre-writing. Learning stories were present on the walls featuring photos of the children in the classes.</p>

General Comments

Educators redirected children and corrected behaviour when necessary using a level tone. They were consistent with messaging and remained calm with the children. Educators were supportive when the children needed help resolving conflict. Educators conversed with the children, engaging in conversations about their Halloween plans and other activities outside of daycare.

I recommend this license for renewal.
