This will be a good time once snow is melted and ground has thawed to loosen mulch around all climbers, clean all toys and equipment and storage bins, check for protruding nails, screws, and other broken toys and equipment.

Monitoring inspection performed. Last years 'Licence' has been issued and emailed. Please post on your parent board. This was completed today during my visit.

Licensing Inspector had a conversation with the Operator regarding Professional Learning (PL) opportunities. After discussion, the Operator reached out to district staff today to check on PL sessions that staff could sign up for. No staff has been attending any PL sessions this past year and it is my understanding that during my visit District staff emailed the operator about some PL opportunities. In order to meet education requirements for

designation, a minimum of 10 hours of PL is required for all educators that have either 1 or 2-year ECE certificate or the 90 Intro to ECE. It is the Operator's obligation to keep track and to document staff PL training hours. The department emailed a form to the Sector which can be used to track this information. Educators may choose to set up a portfolio to keep track of their own PL training also.

Licensing staff reviewed administrative records - attendance of staff and children, fire drills, outdoor check list (see comment above). A reminder about updating SD and CRC/VSC as a few will be expiring in the next couple of months. The Operator advised those staff during the visit.

All children were playing in a variety of age-appropriate activities - babies were busy with mark making, the 2, 3 and 4's were enjoying a sensory bin activity. Children were observed measuring sand, crystals, and rice with a variety of measuring tools, spoons, cups. All children planted a flower bulb in their classroom today. Children made slime with the assistance of their educator, other children were playing with marbles, dolls, looking at books. Lots of easter theme project work and other programming was posted that reflected the curriculum framework. All children were observed - in outdoor play and one educator took the babies for a walk in the stroller. Children were observed washing hands before eating lunches, babies having diaper changes, and the babies and younger preschoolers were observed having a nap. The older preschool age children didnot nap but had a change of pace of activities and enjoyed making 3 batches of different colored slime with their friends. The baby room is nicely organized and inviting. As expressed to educators and to the Operator it was suggested that programming be posted at children's eye level to make it assessable to the children, rather than up high on the wall. This will support children's memory and serves as a jumping off point to extend learning. New items can be added into the environment to ensure the children are provided with new learning opportunities. The 2 and 3's seem very interested in the parts of the body. This would be a great opportunity to introduce a new centre to complement and extend learning on this topic. All staff were attending to children's needs and taking their lead by listening and responding to children, assisting with dressing, toileting. It is important to have an organized routine with transitions. That is, one active group of children didnot seem familiar with the routine - coming in from outside and after removing outdoor gear to go and wash hands prior to eating lunch. This might be a good time to come in earlier so the transition won't be so hurried and maybe move children to a story time while the other staff heat up lunches. It might be helpful to have a 3rd staff available while getting children's food heated, washing hands and then everyone sitting down to eat lunch at the same

Postive child guidance was observed, and licensing staff heard positive language used - alright my friends, that is awesome, you are so creative and playful conversation was heard while changing children's diapers. Children need to be wearing shoes indoors for safety reasons as children can easily slip and fall when wearing socks only. Please remind parents to bring appropriate indoor footware.
