| <p>Monitoring visit performed.</p> <p>Administrative records were reviewed during my visit - attendance, infant info sheets, outdoor checklist, fire drills and staff records. Educators track fire drills and record this in the classroom. I mentioned to educators to ensure they record reasons for absence on the attendance record as it is important to know if the absence is illness related, so they can be watching for signs and symptoms in other children. On the day of my visit, outdoor checklist had not been recorded since summer but the administrator is now aware and will be doing this going forward.</p> <p>All children were observed playing indoors today. It is raining cats and dogs so it really is a miserable day to enjoy outdoor play; though this facility takes children outdoors on a daily basis.</p> <p>One group was observed listening to a story. The educator was observed reading and asking lots of questions about the story, providing gentle reminders to listen and to wash hands. This class is learning about Winter, the gear you wear, what you drink, what activities they enjoy during this season. Other groups enjoying a painting activity, mark making, and listening to calming/christmas music. Lots of interaction and conversation observed. Great science display in the preschool room. These children are learning about what a family is, who is considered family, where they live etc. Educators were observed sitting and eating lunch with the children. All children were observed having a nap/quiet time.</p> <p>I would recommend labelling cribs with children's names in the event you have a relief staff replacing your</p> |
