General Comments

Monitoring inspection performed.

Administrative records were also reviewed and all in order during the day of my visit. One observation regarding filling in the incident report as stated above. Please remind staff also, to enter the time the parent was notified on the incident report

Most children were napping upon arrival. Those children that do not nap - older preschoolers were involved in quiet play opportunities seated at the table in the room where children nap.

Wednesday is a 1/2 day for school age. They were involved in some free play opportunities after eating lunch some were painting, reading, building forts. The plan was to get dressed for outdoor play.

The older preschoolers were practicing - singing and acting out songs for their preschool graduation and following the educator instructions in a language that is understood by this age group. Some children were enjoying this exercise while others chose not to participate. In situations like this always give them an option. The young preschoolers and babies had woken from nap. Some children were having their bottoms changed, others were playing with blocks, dancing to music dressed up in costumes. This group was also going to Williams Street Park. It was observed a child was assisted with washing hands after toileting however the child wiped his wet hands on his clothes. Paper towel was available so please ensure educators take the time to assist children with wiping their hands also. Lots of conversation, logs of hugs was observed in the infant room. All children were observed going outside or to the park. In the outdoor play space educators were observed taking toys, equipment and other materials from the locked shed and made it accessible for the children to play with - brooms, rakes, balls, pails and other outdoor toys.

One group of children is going on a fieldtrip to a farm on Friday. The operator is aware of the new guidelines when children have contact with animals when visiting farms.
