### General Comments

Licensing staff arrived at the license facility to conduct a License Renewal Inspection.

The infants were engaging in a loose parts activity consisting of Christmas bows, small cake pan in the shape of a Christmas stocking, large white poms=poms that looked like snowballs, Christmas ribbons with small Christmas trees, small stuffed snowmen, plastic candy canes and wooden snowflakes. While engaging in the loose parts activity, a child handed the educator the board book called "The Mitten", by Jan Brett. When the educator began to read the book, the other two children quickly went over to hear the story and look at the animals in the book. The educator was very interactive with the infants throughout the morning while licensing staff was observing in this classroom.

The junior preschool children were engaging in a sing-along time while in the story time centre. The children sang "Sleeping Bunnies," "Halloween Shark," "Santa Shark," and lastly, "The Handwashing Song," before washing their hands before sitting down to eat their lunch. Once the children washed up from lunch they went on their cots for quiet time.

The senior preschool children were engaging in an activity using an assortment of cars, trucks, and wheelers along with wooden blocks that the children used as ramps for their vehicle. The educators also laid out a car mat for the children to run their cars along before settling down for quiet time.

After quiet time, licensing staff observed the four-year-old classroom engage in a craft activity consisting of strips of rectangular paper, glue, and markers. When licensing staff asked the children what they were making and the children answered with different answers. One child told licensing staff that she was making a Christmas ornament, another child said, "flowers," while another child said, "a bug." Each creation looked different from the others as the educators encouraged the children to create what they wanted to. Licensing staff heard the educator ask open-ended questions to the children as they created their Christmas ornament.

The school-aged group was also engaging in free play activities on the day of the inspection. One group of children were making slime, while another group of children were playing a game and the child who could pile the most objects on their mat while still sitting on it was the winner. A third group of children were engaging in a

game of "house."

Licensing staff observed the educators using positive child guidance such as redirecting an undesired behaviour along with encouraging children to use their words instead of their hands when they are upset with their friends.

All files were organized and complete with the required information.

Licensing staff recommends the facility for licensing.
