The children were engaged in play during visit. The rooms have been set up with many interest centres and the children are able to interact in any area that they wish.

Outside play was not observed during visit but educators indicated that the children use the top part of the fenced in area and/or the parking lot as the roof the childcare facility is being replaced.

Ensure that the surfacing under the slides is raked regularly to maintain a safe depth and that it is also spread out and pushed away from the structures.
