Educators observed engaged with children at their level providing support and having conversations.</li> <li>-A children's size trampoline was put away during the visit.</li> <li>-Each child has an easily and accessible space to put their personal belongings, this space is identified with the children's name and is intended for the child used only.</li> <li>-During the visit educators shared with me their purposely planned and documented programming, which is planned by following the children's interest. Documentation on the wall, highlights the children's learning and development.</li> <li>-In all rooms, an increase of literacy has been noticed.</li> <li>-Portfolios are at the children's level.</li> </ul> <p>Observations: When arriving at the center children were finishing their snack and were getting ready to go play outside. After playing outside they came in and ate their lunch.</p>
