- -Visit to the center for an unexpected monitoring inspection
- -Ratio was respected during the visit
- -Daily routine into the center includes; Outdoor play time at least once every 4 hour blocks time when the weather is permitting. Meal and snacks are served at the recognized hours and a daily rest period that meets the children's needs.
- Discussion with each educator concerning the connection of the application of the curriculum framework and the early childhood services act. The inspection checklist was shared with the educators and strategies were discussed on how to apply them within the center. A follow-up inspection will be completed to evaluate with the educator if all the items of the regulation are being applied into their classroom.
- -One new staff has begun her 90 hours and two more are waiting to get their training. Once their 90-hour training is done, the non-compliance will be removed.
- -Guidance of the children is done in a positive and respectful way
- -A first-aid kit and a phone are always accessible on site and on outings.
- -Outdoor play area has at least 10% shade
- -Outdoor play area consists of more than one surface to permit different types of play
- -Outdoor material is varied and in sufficient quantity for all children present

Observations: When arriving at the center the four-years-old were going to play outside, the two's were experimenting with their home-made boats. The three's were eating their lunch and the infants were getting ready for their nap.
