<p>General Comments</p> <ul style="list-style-type: none"> -Morning visit to the establishment for an unexpected monitoring inspection -Ratio is respected during the visit -In all rooms where diaper changing stations are found, individual space is provided for diapers and changing necessities. The changing table is equipped with a safety strap and covered with a non-absorbent layer, it is separated from the food preparation and is located one meter or less from a sink and children are always supervised during diaper changing. -Each napping child has a cot or nap mat that is appropriate for their height -There is a space of at least 46 cm between rest equipment and all nap equipment is washable and non-absorbent -Each cot is stored so there is no contact with another napping equipment or are disinfected on both sides after each use -Toxic products, and cleaning supplies are locked and inaccessible to children -Appendix 21 – Staff handbook template was revised, and a copy was given to the operator inviting her to make sure that the staffing plan has all relevant and required information's. -Parent board is posted in the entrance which is a visible and prominent place. All required documents were found on the board. -Indoor environment provides for children a space that is safe and clean. The material is varied and in sufficient quantity for all children present, easily accessible on low, open shelves. -Each child has an easily accessible space for personal belongings, which is labeled with the name of the child and used only for the intended child. -Educators were engaged with children at their level providing support and having conversations while bringing guidance on finding solutions to resolve a conflict <p>Observations: When arriving at the center the three groups of four's, where into projects, one of them was in a math project, the other were drawing their emotions, the third one was reading a book. In the three-year-old room we could see painting project, coloring the group is really into art's and craft. The two's are into car's and track's and finger painting. In the infant's room the children are really into sensory play.</p>
