Renewal Inspection performed.

*The Centre staff is following the Covid Recovery Phase Guidelines. Clear rules posted at the door regarding entrance requirements. Parents have signed the Appendix E regarding their responsibility to screen their children in the AM. Staff also document and track temperatures mid day on children and staff screen in AM and PM. Cleaning schedules for Covid are also being completed and a daily log is kept for each self contained group. The household member list was made available upon my request.

* Programming rooms are nicely organized and inviting making all materials, toys and equipment accessible to the children. Lots of wonderful programming observed displayed and posted. Great interaction observed - giving children and opportunity to talk about their evening before.

* A few observations outdoors - please poke holes in tires so standing water drains out easily, Pea gravel required and sandbox cover needs secured as this is off limits at this time due to Covid-19 as per PH instructions.
