General Comments

Licensing staff arrived at the licensed facility to conduct the license renewal inspection on May 18th, 2022. When licensing staff entered the facility, the three year old classroom children were just finishing up their snack. The children cleaned up from snack and engaged in some free play activities. A group of children built a fort using tables and a blanket while another group of children drew a picture using white paper, pencils and markers. The children were very proud of their creations and licensing staff heard one child say that he wanted to put his drawing in his bag for his mother.

While observing in the four year old classroom, the children painted a very large cardboard box with paint sticks. Licensing staff were very engaged in this activity. Licensing staff heard the follow: "do you like my picture?", "This side is very beautiful!", "you are the bestest teacher!" The children enjoyed this activity!

The educators in all classrooms were very engaged with the children. Licensing staff heard wonderful redirection techniques by the educators. Only positive guidance was heard throughout the inspection visit.

Later in the morning, the entire group sat down at the table to explore playdough. The children were very excited when heir teacher presented them with construction vehicles to help them explore the playdough.
